COVID-19 WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

ADULT AGREEMENT: IN CONSIDERATION of being permitted to participate in any way in the BRAZILIAN JIU JITSU and PHYSICAL CONDITIONING activities (collectively the “BJJ Activities”) offered by New Creation Jiu Jitsu, I _____, for myself and for my personal representatives, assigns, heirs, and next of kin, agree as follows:

I UNDERSTAND AND ACKNOWLEDGE, that novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

New Creation Jiu Jitsu has put in place preventative measures to reduce the spread of COVID-19; however, the Academy cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the Academy could increase your risk and your child(ren)’s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending New Creation Jiu Jitsu and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at New Creation Jiu Jitsu may result from the actions, omissions, or negligence of myself and others, including, but no limited to academy employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to personal injury, disability and death), illness, damage, loss, claim, liability, or expense, of any kind, that I, my child(ren) or next of kin may experience or incur in connection with my child(ren)’s attendance and or participation in New Creation Jiu Jitsu programming.

On behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Academy, its employees, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the Academy, its employees, agents and representatives, whether a COVID-19 infection occurs before, during, or after participation in any program of the Academy.
